ADVERTISEMENT AND REQUEST FOR BIDS concerning REROOFING AT THE GALENA MIDDLE SCHOOL

The Galena USD #120 invites bids for reroofing at the Galena Middle School, 1206 Franklin Street, Galena, IL 61036. In general, the work consists of reroofing portions of the existing building, including new flashings and copings. Base Bid is identified as Galena High School roof as shown on the documents.

Sealed bids shall be submitted to the Galena USD #120, attention Greg Herbst, EdD, Superintendent, no later than 2:00 p.m., Central Daylight Savings Time (CDST), **Thursday, July 27th, 2017**. Bids will be opened publicly and read aloud. Any bid received after 2:00 p.m. CDST on Thursday, July 27th, 2017 will be returned to the Contractor and will not be considered. It is the responsibility of the Contractor to ensure that their bid is received at the time and place set forth above.

The Plans and Specifications contain the details and requirements of construction and related improvements for the Galena Reroofing High School Project. In general, the work of the project includes (but is not limited to): demolition of existing materials, carpentry, roofing, and sealants.

The contracts awarded to the successful Contractors shall be accompanied by a bond, with surety, in the amount equal to 100% of the contract price conditioned for the faithful performance of the contract and the fulfillment of other requirements as provided by law. Performance and Payment Bonds for this project will be on AIA Document A312, or similar document.
